PR PAMPHLET FOR REVIEW

Also attached is the draft pamphlet for professionals, "Narcotics Anonymous and Persons Receiving Medication Assisted Treatment". This pamphlet received approval for creation in the 2014 CAT under Excerpt from the 2014-2016 Strategic Plan Issue: Clear, Consistent Understanding of NA Objective D: Raise understanding of NA as a viable program of recovery among addicts and non- addicts. Approaches: Create a new PR pamphlet (similar to Information about NA) for professionals regarding the medicalization of addiction treatment and the NA Third Tradition. Conference participants at WSC 2014, following discussion, supported that this proposed pamphlet be sent to them for a 90-day review period. Following that agreement, Motion #12, to approve the Public Relations plan for inclusion in the 2014-2016 Narcotics Anonymous World Services, Inc. budget, was presented and

carried through voice vote. The 90-day review period ends 25 April 2016. Please send any input to okna.org by April 1st so that our input can be submitted.

Discussion:

- Ed V discussed the discrepancies in reported Susan S.'s report of Clean and Crazy and the event treasure's report.
- Cindi B. sought clarification on discrepancies the 3-year differential report, particularly related to liability insurance. Was troubled by the treasurer's responsibility to check accuracies of event treasuries and pay unpaid bills.
- Pam T. wondered if the expectations of event committee chairs are clear (especially, being present at region to give final reports) and the required elements of final reports. Emphasized giving a budget 2 months before the yearly activities associated with events (see bylaws).
- Terry F. emphasized that event treasures provide correct detailed reports.
- Kyle B. questioned why we are having delinquent sales tax payments and reporting.
- De L. provided information about receiving petty cash for preparing events and clarified that budgets are submitted by committees, except when expenditures are over \$2000, which needs OKRSC approval.
