In 2023, EASC had about 50k income between main acct and lit. 2024 changes in tax reporting laws for services like Square/Cash App are going to make it critical that Area has a path forward to either file taxes as a business or complete the process to become a 501(3) c non-profit. Not doing so could create liability for our area and its officers. ToeKnee K is participating in the current process for the OK region to establish its new 501(3)C. This would be useful if we choose that path. We will discuss more in the upcoming months and will be asking area for a decision on a path forward.
